| Subject of meeting is 389 Bella Beach<br>Drive or Sunset 389 | <ul> <li>Purpose of the meeting – consider the latest two complaints against 389 Bella Beach Drive, aka Sunset 389. These complaints were filed on July 7 and August 3.</li> <li>Both complaints deal with violation of afterhours use of the hot tub.</li> <li>A \$250 fine was assessed for the prior complaint received on June 16, 2022. Notification of fine sent to owner on July 19. This fine was not appealed by the owners.</li> <li>Meredith Lodging is installing a noise monitor which will notify them when noise decibels reach a specific threshold. At which point they will contact the guests to rectify the situation.</li> <li>Signage about the rules of the community are posted near the hot tub. Guests are informed of the rules by phone prior to arrival and on the day of arrival.</li> <li>Since appears the owners have made a goodfaith effort to address complaint issues, a suspended fine was suggested.</li> </ul> | Dick Chaplain moved, Linda seconded that a fine of \$250 be assessed in suspended status and that the owners be given 90 days for a review to see if there is another violation. Should a violation occur, the fine becomes due and payable. Motion passed unanimously. | Review in 90 days or institute fine if another violation occurs. |
