Subject: Fire pit discussion

While I had planned to attend the Special HOA Board Meeting today to share my thoughts on fire pits, I will not be able to attend due to a family emergency.

1. There is no question about continuing the ban on fire pits due to the current high-risk conditions that exist in all of Oregon. Anytime a recreational fire is started it poses a threat to escape and become something more serious. Fire fighters are in short supply and to call on them due to an escaped recreational fire is nonsensical.
2. I believe that fire pits in Bella Beach HOA controlled areas should be banned permanently and all existing pits be removed. These pits are considered to be recreational fires for the purpose of warming and cooking. These pits exist at residences that fulfill those requirements and thus only exist for entertainment. Renters have continually shown the disregard for HOA rules regarding several topics, including fire pits. I understand that one home owner removed their fire pit after renters left a blazing fire unattended.
3. Fire pits also cause a nuisance with noise and smoke drifting into other home owner homes. The unwanted smoke is a health concern for many of us.
4. There are restrictions on fire pits by Depoe Bay Fire District that are not being followed, such as a 25ft clear area form any combustible material. I have first-hand knowledge that such violations exist and I am unaware that fire pits have been inspected or approved by the HOA.
5. A permanent ban on fire pits would avoid monitoring and decision making on part of the Board. I also question what the liability the HOA Board and members have if a fire escaped containment from a pit.

The bottom line is that with climate change the western states will continue to have high risk of wildfires, and shouldn't we do our part to help reduce that risk along the Oregon coast?
