ARC Membership Turnover: Wecker and Zdanis terms ending in July. Both are willing to continue but are also willing to let other interested homeowners have a turn. We are currently accepting applications and the board will select at the July 12 meeting from among the interested applicants.

ARC Standards and Guidelines: The ARC has developed a Rev 2 to our Standards and Guidelines which the board will vote on at the July 12 meeting.

ARC Enforcement: The ARC discussed the advisability of taking a more proactive enforcement approach to aesthetic violations within the neighborhood. Current practice is to respond to (1) egregious violations of neighborhood aesthetics, or (2) complaints. We must be consistent in what we do enforce. At this time we will continue with this practice.

ACTION ITEM: No parking sign on the rock wall at the SW corner of the neighborhood at the end of Bella Beach Drive is confusing and seems to conflict with existing parking. Kim will look at it and talk to the road district.
